

"Sabadell Seguros Prize Draw"

BanSabadell Vida, S. A. de Seguros y Reaseguros, holder of Tax ID Number A-08371908 and whose registered office is at Calle Isabel Colbrand, 22, 28050 Madrid (hereinafter "**BSV**") and **BanSabadell Seguros Generales, S. A. de Seguros y Reaseguros**, holder of Tax ID number A-64194590 and whose registered office is at c/Isabel Colbrand, 22, 28050 Madrid (hereinafter "**BSSG**"), both companies hereinafter jointly referred to as the "**Promoting Entities**", are organising this prize draw called "Sabadell Seguros Prize Draw" (hereinafter the "**Draw**") for 10 journeys to Iceland with the participation of customers and/or potential customers who carry out an insurance simulation.

PRIZE DRAW RULES

One: Time scope.

Two: Geographical scope. Spain.

Three: Promoted products

Life Care, Life Care Premium, SME Life Protection and Premium Accident Insurance (BSV products), Home Protection, Basic Home Protection and Business and Office Protection (BSSG product), Sabadell Health Protection with "copay", "no copay" or "reimbursement" options; Sabadell Health Protection for the self-employed with "copay" or "no copay" options, and Sabadell 60 Plus Health Protection (BSSG-Sanitas products), distributed through BanSabadell Mediación, Operador de Banca-Seguros Vinculado del Grupo Banco Sabadell, S. A. (hereinafter "**BanSabadell Mediación**"), in accordance with the provisions of these Rules (hereinafter "**Promoted Insurance Products**")¹

Home Protection, Basic Home Protection and Business and Office Protection are multi-risk insurance policies offered by BanSabadell Seguros Generales Sociedad Anónima de Seguros y Reaseguros, holder of Tax ID number A64194590, and whose registered office is at Calle Isabel Colbrand no 22, 28050, Madrid. It is registered in the Madrid Companies Register and in the Insurance Companies Register of the Directorate-General for Insurance and Pension Funds (DGSyFP) under code No. C-0767.

Sabadell Health Protection with "copay", "no copay" or "reimbursement" options, Sabadell Health Protection for the self-employed with "copay" or "no copay" options, and Sabadell 60 Plus Health Protection are insurance policies offered by Sanitas, S. A. de Seguros and BanSabadell Seguros Generales, S. A. de Seguros y Reaseguros, under a co-insurance scheme whereby each company makes a 50% contribution to the co-insurance. Sanitas, Sociedad Anónima de Seguros, holder of Tax ID No. A28037042 and whose registered office is at c/ Ribera del Loira, number 52, 28042 Madrid, Spain, registered in the Madrid Companies Registry and in the Insurance Entity Register of the Directorate-General for Insurance and Pension Funds under code C-320.

Insurance brokered by BanSabadell Mediación, Operador de Banca-Seguros Vinculado del Grupo Banco Sabadell S. A. ("BanSabadell Mediación") and marketed through the network of Banco de Sabadell S. A., an entity with which it has signed a contract for the provision of distribution network services. BanSabadell Mediación's registered office is Avenida Oscar Esplá, 37, 03007 Alicante, and its Tax ID number is A03424223. It is registered in the Alicante Companies Register and in the Administrative Register of Insurance and Reinsurance Distributors of the Directorate-General for Insurance and Pension Funds (DGSyFP) under code No. OV-0004, acting on behalf of BanSabadell Vida, Sociedad Anónima de Seguros y Reaseguros, BanSabadell Seguros Generales, S. A. de Seguros y Reaseguros and Sanitas, Sociedad Anónima de Seguros; having taken out civil liability insurance in accordance with the provisions of prevailing private insurance and reinsurance distribution regulations. You can view the insurance companies with which BanSabadell Mediación has signed an insurance agency contract on the website www.bancsabadell.com/bsmediacion.

Four: Personal sphere. Individual customers who are of legal age and legal entities that carry out at least one simulation of any of the Promoted Insurance Policies between 1 June and 31 July 2025, both inclusive (the "**Participation Period**"), and register for the Draw before 1 September 2025 (the "**Relevant Date**") may participate in the Draw.

Employees and former employees of the Banco Sabadell Group are **expressly excluded** from participating in the Draw.

The Promoting Entities reserve the right to deny participation in this prize draw to anyone who does not comply with any legal requirement or with requirements stipulated in these Rules.

Five: Participating in the draw. Eligible to take part in the draw are people who meet the above requirements and who have voluntarily and duly registered for it at <https://www.sabadellsegurosypensiones.com/es/acciones/sorteo-islandia> between 1 June 2025 and 31 August 2025, both inclusive (the "Participant").

Each simulation carried out during the Participation Period entitles participants to a single entry in the Draw, with a limit of one simulation per product and Tax ID Number, irrespective of the number of simulations carried out and the method or channel through which the simulation or access to the Draw was received.

Six: Prizes. The following prizes will be awarded (collectively, the "**Prizes**", and individually, the "**Prize**"):

10 trips to Iceland for two people (winner and companion) valued at €5,400 (the value of the prize is the cost plus 20%, in compliance with regulations in force, Article 105.1 of Personal Income Tax Regulations, RIRPF), as set out below:

- The journey must be taken by the winner.
- The prize cannot be exchanged for cash or transferred to third parties.
- Waiver of the prize will not entitle the winner to any compensation or indemnity whatsoever.
- The journey will be subject to availability at the time of requesting the services at least 60 days before the departure date.
- Included are the following: return economy class airfare from Madrid or Barcelona to Reykjavik (Iceland).
- Transport to the Madrid/Barcelona airport will be provided from the winner's place of residence (provincial capital). Also included are airport/hotel/airport transfers for travellers and companions in Iceland.
- Included are three (3) nights with bed and breakfast in a 4* hotel.
- The prize does NOT include cancellation insurance.
- The prize can be enjoyed between 1 January and 31 December 2026, except during periods when it is unavailable.
- Period not available for travel: High season (Christmas, Three Kings' Day, Easter, public holidays, long holiday weekends, from 15 June to 15 September).
- If, owing to the advance booking of the journey, it is possible to make a reservation during high season, the agency will offer a valid option.
- The winner will NOT be paid any price differences in their favour that may arise from the requested changes.

The prize will only be awarded to participants who have won following the Draw's process and who comply with all the legal conditions and these rules for obtaining the Prize ("**Winner**").

In the event that the winner is a legal entity, the person travelling will be the director of the winning

company and a companion or a person designated by the winning company.

The Prize may not be exchanged, altered or transferred for another object or service by any Winner and will be subject to the tax obligations established by law.

The Winner may not transfer the Prize.

Seven: Date and process of the draw. The prize will be awarded by means of a random draw conducted using the Easypromos draw application² on the Draw Date.

The draw's process will be as follows:

1. The Promoting Entities will receive all of the simulations for promoted products.
2. BSSG is the promoting entity that will conduct the draw and notify the winners.
3. It will be a random draw amongst the Participants from which ten prize winners will be selected.
4. After the winners are selected at random, ten alternates (the "**Alternate**" or the "**Alternates**") will be designated in the event that the winner does not meet the requirements of these rules for obtaining the Prize. Alternates will be brought on in the same order in which they were designated.

Eight: Notifying the winner and awarding the prize.

BSSG will contact each Participant with the winning Draw number to notify them of their status, using any of the means of communication the Participant has accepted on the registration form and during the days following the Draw date.

BSSG will make up to 2 attempts to contact winners via the means at its disposal.

In order to receive the Prize, the Participant with the winning number must formally accept the Prize by notifying BSSG in the manner specified by BSSG when providing notice of the Draw results. The response will be deemed to have been notified within the time limit if BSSG receives it within 3 calendar days from the day following the day on which BSSG made the first notice attempt.

In said notice, the participant with the winning number must provide at least the following documentation:

- Formal and unconditional acceptance of the prize in accordance with these rules.
- As much information as is necessary to comply with legal requirements.

BSSG will verify compliance with all requirements prior to designating the final status of Winner, reserving the right to conduct as many verifications as it deems appropriate.

In the event that (i) the Winner's acceptance is not received in the required form and within the specified time, (ii) in the event of withdrawal or (iii) in the event that the Winner does not comply with or accept all the conditions necessary to obtain the Prize, the Prize will be deemed forfeited for all legal purposes and, consequently, BSSG may proceed to notify the status of "Draw winner" to the first alternate, and so on following the order of the alternates.

In the event that, for whatever reason, none of the selected participants are able to obtain the Prize, the draw will be repeated.

² "Easypromos" (EASYPROMOS, S. L.) has a tool that issues a certificate of validity for the draws and the random draw operations it carries out. The procedure for selecting winners using the Easypromos tool has been verified by a notary public in a Notarial Verification Certificate dated 16 June 2017 before the notary public of Madrid Celso Méndez Ureña, verifying that (i) the draws carried out through the Easypromos tool are random, and that (ii) the validity certificates obtained cannot be deleted or modified.

The Prize will be awarded within a maximum of 30 days from the time it is verified that the Winner complies with all the legal requirements and these rules in order to receive the Prize after acceptance.

The Winner acknowledges and agrees that BSSG's responsibility for the Draw ends when the Prize is awarded and that the Promoting Entities are not responsible in any way for the services that make up the Prize. These promoting entities do not have any type of corporate relationship with the Prize provider, nor do they have any agency or joint venture relationship; they are two completely separate companies.

The Promoting Entities do not assume or accept any liability for any direct or indirect damage or harm that the Winner may sustain in relation to the services of the Prize providers, who have their own terms and conditions for their products and services.

Nine: Personal data processing

Data controller: The Promoting Entities (BSV and BSSG Seguros Generales) will process the personal data collected for the management of this Draw as independent data controllers.

Purpose: The personal data collected during the draw and those provided in the event of winning will be processed for the purpose of managing and executing the draw, including notice and awarding of the Prize. No profiles will be created based on the personal data processed. The nature of the lottery requires automated decision-making, as it involves a random selection process.

Legal basis: The legal basis for the processing of your personal data is the consent you give when you register for the Prize Draw and accept these Rules.

Recipients: BSV must provide BSSG with the minimum personal data required during the Draw to ensure its proper operation. In this regard, it will communicate your eligibility to participate after you have completed a simulation, the content of which will not be disclosed under any circumstances. Personal data will not be disclosed to third parties unaffiliated with the Draw. No international transfers will be made during this processing either.

Access to your personal data will be limited to third parties to whom the Promoting Entities are legally required to provide access, as well as partners to whom they have entrusted the provision of the services necessary for the management of this Draw, under the agreements and obligations required by law.

Storage: Personal data processed for this prize draw will be kept for two (2) years after the prize has been awarded for the sole purpose of responding to any claims or actions brought before public bodies, judges and/or courts.

Rights: You may exercise your rights of access, rectification, deletion, objection, restriction of processing and data portability. Finally, if you believe that your rights have not been properly respected, we inform you that you have the right to contact the Data Protection Officer through the channels stated at the beginning of this clause, as well as the Spanish Data Protection Agency (AEPD).

Ten: Taxation. In accordance with current tax regulations, prizes awarded for participation in games, contests, raffles or random combinations, whether or not related to the offer, promotion or sale of certain goods, products or services, are subject to withholding or payment on account of 19%, provided that the withholding base of the prize exceeds €300. BSSG will make the payment on behalf of the winner to the Public Treasury and undertakes to comply with the obligations to provide information to the Spanish Tax Administration Agency and to the winner arising from the award of the prize. Such withholding or payment on account will be paid by BSSG and therefore increase the prize's value.

Eleven. Acceptance of the rules. By participating in this Prize Draw, participants accept its legal rules and the criteria of the insurance companies regarding the resolution of any matters arising therefrom.

The Promoting Entities reserve the right to declare the Draw void in the event that the Winners or Alternates do not meet the requirements set out in these rules or waive their rights. Likewise, the Promoting Entities reserve the right to modify the conditions of this promotional campaign at any time, including its possible cancellation before the pre-established time limit. They likewise undertake to provide notice of the promotional campaign's new rules or its definitive cancellation.
